## **Section V. Term and Appointment Notes**

- All terms are three years, pursuant to § 58-64A-370(c).
- Members may serve two consecutive terms.
- Members continue to serve until a successor has been appointed.
- Vacancies must be filled by the original appointing authority for the remainder of the unexpired term.
- Staggering of terms should be maintained so that no more than five terms expire in a single year, consistent with Article V of the bylaws.
