#### **COMMISSIONER'S CORNER**

As we enter the final quarter of 2025 and cooler weather, the North Carolina Department of Insurance remains as active as ever. It has been a productive year, with our divisions helping residents and protecting consumers in many ways. As I travel the state, I often meet people grateful for our assistance with claims, questions, and appeals, and I value the input I receive from agents and adjusters along the way.

Our regional directors, field agents, and SHIIP counselors remain deeply engaged in educating communities about the risks of insurance fraud and scams—and how to combat them using the many resources we provide. Meanwhile, CID agents in our Fraud Control Group continue their tireless efforts to remove bad actors from our streets and raise awareness of the havoc fraud can cause and how the public can avoid costly scams.

I'm actively working on behalf of consumers to promote hurricane preparedness, the benefits of fortified roofing, flood insurance education, and fire prevention strategies for the home. I'm also helping to spotlight the dangers of distracted driving and speeding—critical issues that affect us all.

In early June we reached a settlement with the N.C. Rate Bureau on automobile insurance rates. The settlement provides for an average statewide increase of 5%, which is 17.6 percentage points lower than what the Rate Bureau requested in February. The agreement also includes an average statewide 16.3% decrease in motorcycle liability insurance rates.

With factors such as distracted driving, excessive speeding and increased automobile repair costs putting upward pressure on insurance rates, it's good for consumers that we were able to hold the average increase to 5%. I'm pleased that the agreement will keep North Carolina's average automobile premiums among the lowest in the nation.

I'm proud of our award-winning SHIIP program, powered by the dedication of our exceptional volunteers—each of whom is now preparing for the upcoming Medicare Open Enrollment Period. We're grateful that SHIIP received the necessary federal funding to continue its vital work, and we remain committed to working with state legislators to ensure the program is fully supported at the state level as well.

So, throughout the Department of Insurance we are always looking for new ways to provide the best service for the people of North Carolina. We are looking forward to a great finish to 2025 and preparing for an even better 2026.

## FROM THE **DEPUTY'S** DESK

North Carolina's insurance industry is undergoing significant updates with the passage of House Bill 737 (HB 737). Enacted during the 2025 legislative session and becoming Session Law 2025-45 when signed by the Governor on July 1, 2025; this law introduces a range of reforms that affect both current and future licensees, touching on everything from licensing requirements and commission rules to payment integrity and consumer protection.



One of the most notable changes is the elimination of the pre-licensing education (PLE) requirement. Effective October 1, 2025, any individual who applies for an insurance license in North Carolina will not be required to complete PLE before sitting for the state exam. This change gives applicants more flexibility in how they prepare, whether through formal courses, self-study, or a combination of methods.

In addition to opening the door for new licensees, HB 737 also clarifies long-standing confusion around commission sharing and referral practices. Effective July 1, 2025, licensed insurance producers may now exchange business and split commissions involved with that business, as long as both parties are licensed in all lines of insurance involved in the exchange and duly appointed as required by statute; and provide written or electronic notification to the insurer and consumer of the business exchange. This allows for greater collaboration between producers, including those at different agencies, or operating under independent contracts while still providing consumer protection through required notification.

Further, HB 737 reinforces and clarifies how unlicensed individuals may receive compensation for referring potential customers to licensed insurance producers. Effective October 1, 2025, there is a cap of fifty dollars (\$50) on referral fees associated with referrals to a producer licensed under N.C. General Statute §58-33-26(c1)(6), this applies to any referral of personal lines insurance business. This provision preserves consumer protection while allowing licensed producers to incentivize word-of-mouth referrals in a controlled and compliant manner.

Finally, HB 737 addresses credit card payments and policy cancellations. Effective July 1, 2025, if a premium payment is made by credit card, which is later disputed resulting in a chargeback, then this can be considered by the insurer as a nonpayment of premium. In such cases, any cancellation permitted by statute shall be effective retroactively to the date that the premium payment was made by credit card. With this provision it is imperative that producers and agencies ensure their clients understand that disputed credit card chargebacks could result in a loss of coverage.

While some of these changes went into effect immediately when HB 737 was signed into law, others are effective at a later date and so it is imperative that any licensed insurance professional in North Carolina make themselves fully aware of these changes by reviewing the bill in its entirety which can be found on the NC General Assembly website.
