**VOLUNTARY SETTLEMENT
AGREEMENT**

NOW COME, Christopher Calvin Purvis (hereinafter "Mr. Purvis") and the Bail Bonds Regulatory Division of the North Carolina Department of Insurance (hereinafter "BBRD"), and hereby voluntarily and knowingly enter into the following Voluntary Settlement Agreement (hereinafter "this Agreement"):

WHEREAS, the BBRD has the authority and responsibility for enforcement of the insurance laws of this State, and for regulating and licensing bail bondsmen; and

WHEREAS, Mr. Purvis is currently licensed by the BBRD as a surety bail bondsman;
and

WHEREAS, pursuant to N.C. Gen. Stat. § 58-71-80(a)(7), the Commissioner may deny, suspend, revoke, or refuse to renew any license under Article 71 of Chapter 58 of the North Carolina General Statutes for failure to comply with or violation of the provisions of Article 71 of Chapter 58 of the N.C. General Statutes or of any order, rule or regulation of the Commissioner; and

WHEREAS; pursuant to N.C. Gen. Stat. § 58-2-69(c) provides that if a licensee is convicted in any court of competent jurisdiction for any crime or offense other than a motor vehicle infraction, the licensee shall notify the Commissioner in writing of the conviction within 10 days after the date of the conviction, which includes an adjudication of guilt, a plea of guilty, or a plea of *nolo contendere*; and

WHEREAS, Mr. Purvis was charged with DWLR/Not Impaired in Martin County, NC on January 19,2022 (22CR18) and convicted of that charge on August 08,2022; and

WHEREAS, Mr. Purvis did not report his August 08,2022 conviction within 10 days

after the date of the conviction as required by N.C. Gen. Stat. § 58-2-69(c), and is therefore in violation thereof; and

WHEREAS, Mr. Purvis's violation of N.C. Gen. Stat. § 58-2-69(c) demonstrate a failure to comply with and/or violation of the provisions of Article 71 of Chapter 58 of the North Carolina General Statutes for which Mr. Purvis's surety bail bondsman's license could be suspended or revoked; and

WHEREAS, in lieu of an administrative hearing on the matters stated herein, Mr. Purvis has agreed to settle, compromise, and resolve the matters referenced in this Agreement, and the BBRD has agreed not to pursue additional civil ramifications; including penalties, sanctions, remedies, or restitution based on these matters against Mr. Purvis; and

WHEREAS, pursuant to N.C. Gen. Stat. § 58-2-70(g), the Commissioner of Insurance and the Department have the express authority to negotiate a mutually acceptable agreement with any person as to the status of the person's license or certificate or as to any civil penalty or restitution; and

WHEREAS, Mr. Purvis agreed on October 21, 2022 to execute a Voluntary Settlement Agreement and pay a fine in the amount of \$500.00 as a condition to being licensed as a surety bail bondsman; and


NOW, THEREFORE, in consideration of the promises and agreements set out herein, the Department and Mr. Purvis hereby agree to the following:


1. As set forth above, Mr. Purvis shall remit a **civil penalty in the amount of \$500.00** to the Department. The form of payment shall be in the form of a certified check, cashier's check or money order. The check or money order for the payment of this civil penalty shall be payable to the "North Carolina Department of Insurance." Mr. Purvis shall send the civil penalty by certified mail, return receipt requested or delivered in person, to the BBRD simultaneously with the return of this Agreement, signed by Mr. Purvis. The civil penalty and the signed Agreement must be received by the BBRD no later than **December 31, 2022**. The civil penalty shall be subject to disbursement in accordance with the provisions of Article IX, Section 7 of the North Carolina Constitution for the benefit of the public schools.
2. Mr. Purvis shall obey all laws and regulations applicable to all licenses issued to him.
3. Mr. Purvis enters into this Agreement freely and voluntarily and with knowledge of his right to have an administrative hearing on this matter. Mr. Purvis

understands that he may consult with an attorney prior to entering into this Agreement.

4. This Agreement does not in any way affect the BBRD's disciplinary power in any future follow-up examinations of Mr. Purvis, or in any other cases or complaints involving Mr. Purvis.
5. The parties to this Agreement agree that this Agreement shall have the full force and effect of an Order of the Commissioner. Mr. Purvis understands that N. C. Gen. Stat. § 58-71-80(a)(7) provides that a surety bail bondsman's license may be revoked for violating an Order of the Commissioner.
6. This Voluntary Settlement Agreement, when finalized, will be a public record and is not confidential. All licenses issued by the BBRD to the licensee shall reflect that Regulatory Action has been taken against the licensee following the execution of this Agreement. The BBRD is free to disclose the contents of this Agreement to third parties upon request or pursuant to any law or policy providing for such disclosure.
7. This Settlement Agreement shall become effective when signed by Mr. Purvis and the BBRD.
