**CONSENT ORDER**

This matter came on for hearing before the undersigned hearing officer, as designated by the North Carolina Commissioner of Insurance, hereinafter "Commissioner," on March 29, 2006, in the Dobbs Building, 430 North Salisbury Street, Raleigh, North Carolina. The parties enter into the following Consent Order, hereinafter "this order," to resolve this matter that is currently pending before the undersigned Hearing Officer.

The parties stipulate to the following facts and conclusions of law:

1. Notice in this matter was timely and properly effected and the Commissioner has jurisdiction over the parties and the subject matter pursuant to Chapter 58 of the North Carolina General Statutes. Furthermore, there are no other procedural defects and there is no other pending review of this matter.
2. Robert L. Trumpler, Jr., hereinafter "Mr. Trumpler," currently holds licenses as a Life & Health Insurance Agent and Medicare Supplement/Long Term Care Insurance Agent, issued by the North Carolina Department of Insurance, hereinafter "Department," pursuant to the provisions of Article 33, Chapter 58 of the General Statutes of North Carolina.

3. On or about July 17, 2000, summary judgment was granted in favor of plaintiff James E. Long, Commissioner of Insurance of North Carolina and Liquidator of the International Workers' Guild Health and Welfare Trust Fund against Trumpler for \$1,679.30. This judgment was for unpaid claims related to his sale of insurance for an entity that was not authorized to transact insurance business in North Carolina. Trumpler has not satisfied this judgment. Trumpler's failure to pay this judgment is evidence of financial irresponsibility in the conduct of business in North Carolina.

It is ordered and agreed that:

1. On or before May 10, 2006, Trumpler shall pay the Commissioner of Insurance, as the Liquidator of the International Workers' Guild Health and Welfare Trust Fund, one thousand six hundred seventy-nine dollars and thirty cents (\$1,679.30).

2. Contemporaneously with his execution of this order, Trumpler shall pay a civil penalty of two hundred fifty dollars (\$250.00) to the Department. The form of payment shall be in a certified check, cashiers check or money order. The check or money order for the payment of this civil penalty shall be payable to the "North Carolina Department of Insurance."

3. This order, when finalized, will be a public record and is not confidential. Any and all licenses issued by the Department to the licensee shall reflect that regulatory action has been taken against the licensee following the execution of this order. The Department is free to disclose the contents of this order with third parties upon request or pursuant to any law or policy providing for such disclosure.

4. Mr. Trumpler enters into this order freely and voluntarily and with knowledge of his right to have an administrative hearing on this matter. Mr. Trumpler understands that he may consult with an attorney prior to entering into this order.



5. This order resolves all matters set forth in the Notice of Administrative Hearing in this case, however, nothing in this order shall be construed to affect the Department's disciplinary power in any future complaints or investigations involving Mr. Trumpler.

6.. The Commissioner retains jurisdiction over the parties to this order.
